**Bill: 1<sup>st</sup> substitute HB 69 – Drinking Water Restructuring Amendments**

Sponsor: Representative Albrecht

Floor Sponsor: Senator Stratton

**UASD Position: Support**

This Bill addresses violations of the Safe Drinking Water Act.

Discussion: The sponsor motioned to concur with the amendments made by the Senate. There was no further discussion.

Yeas: 68

Nays: 1

**Outcome: The House concurred with the Senate and 1<sup>st</sup> substitute HB 69 passed out of the House.**

**Bill: 1<sup>st</sup> substitute HB 215 – Landscaping Restrictions Amendments**

Sponsor: Representative Peterson

Floor Sponsor: Senator Vickers

**UASD Position: Support**

This Bill restricts a county, municipality, or homeowner association from prohibiting removal of vegetation on property located in a wildland-urban interface area.

Discussion: The sponsor presented the Bill. Representative Thurston questioned the definition of “Wildland Urban Interface” and asked if it is currently defined by the Utah Wildland Urban Interface Code or the International Wildland Urban Interface Code. It was clarified that it is defined in both.

**Bill: HB 236 – Truth in Taxation Amendments**

This Bill addresses property tax increases through truth in taxation.

Discussion: The sponsor presented the Bill and emphasized the necessity for communication between entities and stakeholders. The 1<sup>st</sup> substitute was adopted by the House. There was no further discussion.

**Bill: 1<sup>st</sup> substitute HB 309 – Juneteenth Observation Amendments**

Discussion: The sponsor presented the Bill. Representative Maloy asked what day Juneteenth is celebrated. It was clarified that the holiday takes place on June 19<sup>th</sup>. There was no further discussion.

**Bill: 1<sup>st</sup> substitute HB 87 – Animal Crime Victim Amendments**

This Bill modifies provisions related to the release and forfeiture of an animal that is being held because of abuse or involvement in a crime.

Discussion: The sponsor presented the Bill. Representative Albrecht questioned the classification of hunting dogs, and it was clarified that hunting dogs fall into the category of farm animals.
